As a result, the number of voter participation areas may vary.

**Utah Code 20A-7-401.3(2) states that a fifth class county and sixth class county are not divided into voter participation areas. However, Utah Code 20A-7-601(3) states that a referendum on a land use law within a fifth or sixth class county must obtain signatures within voter participation areas.
