QUALIFICATIONS FOR THE PRESIDENT OF THE UNITED STATES OF AMERICA

Before the filing officer accepts a declaration of candidacy, the filing officer shall read to the candidate or designated agent the constitutional and statutory qualifications for candidacy as listed below, and the candidate or designated agent shall state whether the candidate fulfills the qualifications. United States Constitution, Article II, Section I:


- Natural born citizen of the United States of America
