QUALIFICATIONS FOR THE PRESIDENT OF THE UNITED STATES OF AMERICA

Before the filing officer accepts a declaration of candidacy, the filing officer shall read to the candidate or designated agent the constitutional and statutory qualifications for candidacy as listed below, and the candidate or designated agent shall state whether the candidate fulfills the qualifications. If the candidate or designated agent indicates the candidate does not meet the qualifications, the filing officer shall decline the declaration of candidacy. Refer to Utah Code Annotated § 20A-9-201, 202.

United States Constitution, Article II, Section I:

- Natural born citizen of the United States of America
- At least 35 years old at the time of taking the oath of office
- Resident of the United States for 14 years

Utah Code Annotated § 20A-9-803:

- Pay a filing fee of \$500.00
- Provide a letter from the state political party certifying that the candidate may participate as a candidate for that party in that party's presidential primary election
