

PETITION FOR INCORPORATION OF LAKE POINT CITY

To the Honorable Lieutenant Governor:

We, the undersigned voters, and owners of private real property located within the area described for incorporation as proposed in this petition, and with the proposed city name of Lake Point City, respectfully petition the lieutenant governor to direct the county legislative body to submit to the registered voters residing within the area described in this petition, at the next general election, the question of whether the area described should incorporate as a municipality. Each of the undersigned affirms that each has personally signed this petition and is a registered voter who resided within the described area, and that the current residence address of each is correctly written after the signer's name. The area proposed to be incorporated as a municipality is described as follows on the attached legal boundary description and accompanying map and is proposed to be named Lake Point

IF THE INCORPORATION MEASURE PASSES & IN ACCORDANCE WITH UTAH LAWS ON MUNICIPAL INCORPORATION SIGNERS OF THIS PETITION APPOINT THE SPONSORS, TO REPRESENT THE SIGNERS IF THE VOTERS CHOOSE THE COUNCIL MAYOR FORM OF GOVERNMENT TO SELECT THE NUMBER OF COUNCIL MEMBERS THAT WILL CONSTITUTE THE CITY COUNCIL IN THE NEW CITY; IF VOTERS DECIDE TO ELECT COOUNCIL MEMBERS BY DISTRICT TO DRAW SUBSTANTIALLY EQAUL IN POPULATION DISTRICT BOUNDARIES FOR EACH COUNCIL MEMBER DISTRICT & TO DETERMINE INITIAL TERMS FOR EACH EELCTED OFFICIAL. IT IS UNDERSTOOD BY SIGNERS THAT BEFORE MAKING THESE DETERMINATIONS THE SPONSORS WILL ADVERTISE AND HOLD A PUBLIC HEARING IN THE FUTURE MUNICIPALITY ON THE ITEMS DESCRIBED.
